- **Wallet Addresses:** Stored in encrypted form to enable transaction processing and access.
- Transaction Data: Public blockchain transaction records for trading, liquidity provision, and token launches.
- **Platform Analytics:** Anonymous usage data to improve performance and user experience.
- **KYC Information:** Identity verification for regulatory compliance, required only for certain features.

#### 3. How We Use Your Data

Your information is used to:

- Ensure the security of transactions and platform operations.
- Verify eligibility for certain features and token listings.
- Analyze and improve platform performance and usability.
- Comply with legal and regulatory requirements.

We never store private keys or sensitive wallet credentials on our servers.

• End-to-end encryption for all stored data.

- Secure Socket Layer (SSL) encryption for web traffic.
- · Regular security audits and vulnerability assessments.

Only authorized personnel have access to encrypted data.

PumpSwap operates on the Solana blockchain. While all transactions, token launches, and liquidity provisions are publicly recorded, user identities remain pseudonymous. Blockchain transparency ensures accountability while protecting personal privacy.

We use essential cookies for login sessions, user preferences, and platform functionality. PumpSwap does **not** use tracking cookies for advertising purposes and does not share cookie data with third-party marketing services.
